

*Any person who had met with an accident while working or commuting in Japanese territory is eligible for reimbursement of the expenses required for the purchase of an upper and lower limb prosthesis or a wheelchair while living abroad.*

### Persons Eligible for Reimbursement

- A person who falls under the following ① and ② and who applied for, and was approved of, the purchase of an artificial arm, an artificial leg or a wheelchair.
  - ① An upper and lower limb prosthesis  
A person who lost an upper limb or the whole or part of a lower limb while living in Japanese territory.
  - ② A Wheelchair  
A person who was disabled or lost both limbs due to an accident he had while working or commuting in Japanese territory and who is unable to use artificial legs and the outfit for lower limbs.

### Method of Application for Reimbursement

- Please apply in accordance with the following procedure:
  - ① It is necessary to make an application to, and be approved of the application by, the Chief of the Labor Standards Bureau concerned when a person requests the payment of the expenses required for the purchase of an upper and lower limb prosthesis or a wheelchair. When applying, he must attach an estimate covering the cost of manufacture of the artificial arm, artificial leg or wheelchair in question and its specifications.
  - ② A person whose application was approved by the Chief of the Labor Standards Bureau concerned can purchase an upper and lower limb prosthesis or a wheelchair.
  - ③ Please apply for reimbursement of the expenses required for the purchase to the Chief of the Labor Standards Bureau concerned with documents attached, including a receipt that certifies the amount paid.

### Others

- The expenses related to travelling expenses and repair when purchasing should not be paid.
- When a person, already supplied with an upper and lower limb prosthesis or a wheelchair, wants to have either of them sent from Japan, he should notify the authorities concerned to that effect.
- Since the life period of an artificial arm, an artificial leg or a wheelchair is prescribed, a new one should not be supplied in principle unless its life period is expired.
